## **Proclamations**

Sign a proclamation to show your support for Registered Apprenticeship.

### **Get Started with Templates**

DOL created editable NAW Proclamation Templates for City, State, Education, and Industry. Follow the steps below to download the Word Document and modify the Proclamation for your organization.

- 1. Download Proclamation Template(s) in one of three ways; each option will lead to the same document and download as a Word Document.
  - a. Click the applicable Proclamation from the hyperlink below:
    - i. <u>City</u>
    - ii. <u>State</u>
    - iii. <u>Industry</u>
    - iv. <u>Education</u>
  - b. On the <u>Illinois Apprenticeship Week 2024</u> page, scroll to the Resources section, and select the applicable Proclamation.
  - c. On the <u>DOL Resources</u> page, scroll to the Proclamation Resources section, and select the applicable Proclamation.
- 2. When the document prompts to download, update the File Name to include your organization's name, then click Save.
- 3. Open the Proclamation Word Document and select Enable Editing if the yellow bar displays at the top.
- Read through the NAW Proclamation and follow the prompts to input your organization's information in the designated areas with [brackets holding gray highlighted text]. Each area will state what information to input, such as the Organization Name, City Name, Industry
  - a. For the Industry Proclamation Template, add your Organization's Name
  - b. entered on the top li
- 5. Remove any remaining brackets and unhighlight text.
- 6. Add your organization's logo where the logo box displays at the bottom.
  - a. Copy/paste an image
- 7. Delete the logo box placeholder once your logo is added.
- 8. Review the information before clicking Save.

#### Submit to ApprenticeshipUSA
