

#### Renewal

**Round 1 –** 19 grantees were offered a renewal on September 20,2023.


Applications for round 1 are due on October 6, 2023 by 5 PM CT.

**Round 2 –** 8 grantees are within range of earning a renewal invitation in October.

Data for round 2 will be pulled on October 13, 2023







#### **Compliance Trends**


In 2023, ILWPP shifted from measuring compliance based on reported data to measuring based on verified data as part of the rolling close out process.

Though in Q1 '23 compliance averages were significantly lower than Q1 '22 compliance, there was a positive trend through Q3 '23.

In Q3 '23, average compliance surpassed Q3 '22 by 7%.



# ILWPP Grantee Manual Updates




ILWPP has a rolling list of updates to make to the Grantee Manual each grant year.

Changes are often rooted in common questions and concerns from grantees. Others are based on guidance or changes required by new legislation or from DCEO leadership.

This section provides a look into changes that have already been approved but does not include all changes that are being considered.

## ILWPP Grantee Manual Updates



- Stipend maximum increased to \$14.25/instructional hour
- Grant award per participant average increased to \$11,000
- Addition on digital literacy as a wrap-around service
- Policy regarding data entry plans/data quality management
- Guidance on safety requirements during work-based learning/practicums
- ILWPP Grantee interaction with the ILW Bid Credit Program





#### **IWRS** Updates




Unlike the Grantee Manual that is updated annually, IWRS is being updated on a rolling basis throughout each grant year.

Based on the evaluation by NIU's Center for Governmental Studies, one of the major improvement areas for ILWPP is improving grantee experience in IWRS.

As a result, ILWPP has developed a committee to evaluate, approve, and implement changes in IWRS

- Enhancements to the Student Support Utilization report and Postassessment and Attendance Report




# **IWRS Update Brainstorm**
